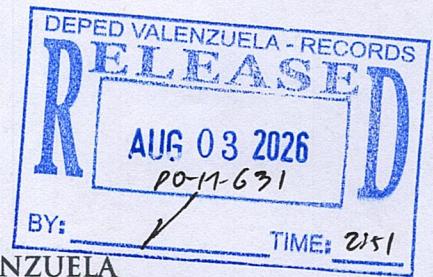

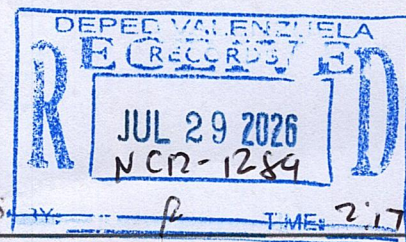

3. Certificates of Recognition will be awarded to the participants for serving as LREs members in this activity;
4. To guarantee the effectiveness of the evaluation and review, LREs members should prioritize maintaining their physical fitness.
